
16-303 Land Management Tracking Procedure Policy 07-08-07

It is FURTHER RESOLVED that the City of Corner Brook shall retain sufficient land at this location for the continued operation of fire hydrant 342. **MOTION CARRIED.**
- 16-308** **Purchase of Land for Main Street Bridge Replacement & Road Widening**
On motion by Councillor Murphy, seconded by Councillor Carey, it is RESOLVED that Council approves the purchase of 163 square metres of land at Main Street owned by GDR Enterprises Limited to allow for widening and replacement of the Main Street Bridge to occur. **MOTION CARRIED.**
- 16-309** **Memorandum of Agreement - Water Agreement with Memorial University**
On motion by Deputy Mayor B. Staeben, seconded by Councillor Buckle, it is RESOLVED to approve the execution of the Memorandum of Understanding dated November 7, 2016 between the City of Corner Brook and Memorial University for the provision of water and sewer services to Grenfell Campus. **MOTION CARRIED.**
