#### Purpose:

- 1. To specify membership dues, professional, license and other fees which will be paid by the City of Corner Brook on behalf of staff.
- 2. To specify the organizations in which the City of Corner Brook should maintain membership

#### Policy Statement:

- 1. The City of Corner Brook will pay membership dues, professional or licence fees:
  - A. If membership in an organization is a requirement of the employee's job.
  - B. If the City derives benefit from the employee's membership in an organization.
