## Purpose:

The purpose of this busking policy is to ensure that any person who performs on a sidewalk located in the City of Corner Brook will not pose a hazard to the public or impede pedestrian traffic flow.

## **Policy Statement:**

Any person(s) performing on a City of Corner Brook sidewalk will be required to obtain a permit and must adhere to the detailed action outlined in this policy.

# **Detailed Action Required:**

#### Permit Fee: \$20.00 Temporary Use Permit (Student Exemption Apply)

The following conditions apply to every street performer within the City of Corner Brook.

- 1. The applicant must be at least 18 years of age or have a parent or guardian's written authorization.
- 2. A written description of the performance shall be submitted for approval with the application form and any subsequent proposals for changes to the performance shall also be submitted for approval.
- 3. An application may be submitted to any other agency as deemed appropriate if it is determined by the department that there is a threat to public health and safety and should any agency have any objections to issuing the license it will not be granted by the department.
- 4. No performance shall be given in areas that are residential.
- 5. No performance shall be given between the hours of 10:00 p.m. and 9:00 a.m.
- 6. Performances shall be limited to sidewalks.
- 7. A performer shall remain mobile and rotate the location of his or her performance at minimum intervals of 90 minutes.
- 8. A performer shall keep each performance location in a neat and clean condition.
- 9. A performer shall prevent, where possible, the throwing of litter in a performance location, on the adjacent street, or on other properties.
- 10. A performance shall not be conducted in a manner that interferes with or obstructs the movement of pedestrians or disturbs the businesses and residents in the area.
- 11. Prior to being granted a permit, an applicant or in the case of a person under the age of 18 their parent or guardian shall sign an agreement indemnifying the City and agreeing to comply with any City of Corner Brook By-Law that may apply, including but not limited to City of Corner Brook Noise Regulations.
- 12. Separate approvals would be required for any Open Spaces, Parks and Special Events within the City. (Ex. East Meets West, Corner Brook Day, etc.)
- 13. Performers must demonstrate a reasonable degree of proficiency in their performances.

- 14. Approvals may be suspended if complaints regarding a busker are received or if performers conduct themselves in an unsafe and undesirable manner.
- 15. Performers acknowledge that they are performing for a family audience and must refrain from the use of lewd or offensive conduct or language in the course of their performance.
- 16. Performer must ensure that their performance doesn't directly or indirectly compromise the safety and enjoyment of the viewing public.
- 17. Any form of entertainment that includes a fire source would require a fire extinguisher to be present and visible at location of event within 5 meters of the performance.
