

**Issue:** This RFD is intended to address the full-time resident inspection during the construction of the intersection, including reporting to the City, supervision of the contractor and final inspection of the work.

**Background:** The Confederation Drive/West Valley Road Roundabout is funded under the Canada/ Newfoundland Rural and Northern Communities Infrastructure program and consists of the construction of a new roundabout at the intersection of Confederation Drive and West Valley Road. The City of Corner Brook has retained Harbourside Engineering Consultants to provide engineering design and contract administration for the project and a PCA is in place for that work. At the time of the original RFP for the work, there was a possible option that due to limited capital works projects scheduled for the 2020 construction season; residential inspection services for this project may have been achieved using existing City engineering department staff. Due to other work commitments and the expected level of effort expected for the roundabout, this option is no longer available and outside resources are required to oversee the work.

**Recommendation:** Staff recommends Option 1, that the Council of the City of Corner Brook approve the Amendment No. 1 from Harbourside Transportation Consultants in the amount of \$39,916.50 (HST Included), for an increase in consulting services related to the Confederation Drive/ East Valley Road Roundabout and that the following motion be supported:



# Council Briefing Note

### Subject: Youth Advisory Committee Meeting Report Date of Meeting: May 25, 2020

The Youth Advisory Committee members held a virtual meeting on May 20, 2020. Outlined below is an overview of some topics that were discussed, as well as some new projects that the Committee is working towards:

**Grant** – One of the members of the Committee submitted an application to a grant organization called Rising Youth and that application was approved for a grant of \$1500. The Committee is working on some ideas and messages for the signs and are going to attempt to seek out guidance to ensure the messages are inclusive and appropriate from a Mental Health perspective. The Committee will be working with a local company to have the signs produced and then the plan is to post them throughout the City.

**T-Shirts** – T-shits with the Youth Advisory Committee logo were unveiled to the Committee and will be distributed to members within the next couple of days through no contact delivery.

**Community Gardens** – The committee is planning to make arrangements to reserve a plot in one of the three new community gardens that are being added in the City. They plan to work at the garden over the summer collectively with hopes to take anything that comes from their harvest and donate it to a local community group. They are planning to reach out to the Executive Director of the Western Environment Centre to help them set up. The group are planning to make a schedule so that the garden can be maintained by all members of the group but still ensure social distancing.



**Social Media/Fitness** – The Communications Officer discussed some plans to develop an Instagram page for the City and some options for the Youth Committee to work on that, as well as try to incorporate some virtual fitness ideas with the month of June being Recreation Month. The Committee's plan is to hopefully collaborate with the Communications Officer on those projects in the near future.

#### Issue:

The City of Corner Brook has received an application requesting permission to operate a home based business (nail salon) from the dwelling located at 13 Bayview Heights which is located in a Residential High Density Zone.

#### Background:

A notice was delivered to the residents in the immediate area of 13 Bayview Heights indicating the proposed home based business. As a result of this notice, three (3) submissions were received. Parking was the only concern of the residents and it has been reviewed and sufficient parking is present based on the current City of Corner Brook Development Regulations. Also, due to the ongoing COVID-19 pandemic, certain restrictions on the operation of certain businesses (including nail salons) have been put in place. After review of the application and the results of the notice to the residents, the Development & Planning Department is recommending that approval be granted for the operation of the home based business from the dwelling located at 13 Bayview Heights subject to the applicant only having one (1) client at any given time in the premises, the condition that should problems arise due to the operation of the nail salon, the City of Corner Brook reserves the right to revoke any granted approval for the said nail salon at this location and the commencement of operation and the operating of the nail salon fully comply with the COVID-19 restrictions currently in effect for the province of Newfoundland & Labrador.

The City of Corner Brook has received an application to operate a home based business (Nail Salon) from the dwelling located at 13 Bayview Heights which is located in a Residential High Density Zone.

A home based business is a "Discretionary Use" of the City of Corner Brook Development Regulations for this zone. A notice was delivered to the residents in the immediate area of 13 Bayview Heights indicating the above mentioned request. As a result of this notice, the City received one (1) phone call and two (2) email messages.

The nature of the concerns brought forth in all of the correspondence to the City was parking. It was conveyed to me that this area can difficult to navigate during the winter months with regard to driving a vehicle and if other vehicles are parked on the side of the road this task can be extremely tricky. While the proposed development meets the parking requirements (one space for each of the dwelling units and one for the proposed home based business), the concerns from the residents are valid. After communicating with the applicant, it has been conveyed to me that if approval is granted, there will only be one client at a time visiting the premises. In an effort to alleviate the concerns of the residents in the area, I am suggesting that should approval be granted for this development, there is a condition of approval that only one client visits the premises at any given time and that should problems arise with regard to the operation of this home based business (including parking on-street parking problems) the City of Corner Brook reserves the right to revoke the said approval of the home based business.


Also, during this time due to the recommendations of the Chief Medical Officer of the province of Newfoundland and Labrador, there are restrictions due to the ongoing COVID-19 pandemic. One of these current restrictions is that hair/beauty salons (which includes nail salons) currently cannot operate. As a result, should approval be granted by Corner Brook City Council for this development, a condition shall be attached to the approval which indicates that the startup of the salon shall only commence once the aforementioned restrictions have been lifted.

After review of the application and the results to the notice to occupants, it appears that there is no impediment for this development to commence subject to the above noted conditions being attached to any development permit issued by the City of Corner Brook.

### **Recreational Vehicles Regulation, 2019**

In accordance with Section 39 of the City of Corner Brook Act, a notice of motion is required for the amendment, repeal and passing of bylaws/regulations of the City of Corner Brook.

Whereas sections 201 and 202 of the City of Corner Brook Act authorize Council to make regulations:

• Prohibiting or controlling the operation of recreational vehicles not licenced under the Highway Traffic Act on public roads and bridges;

And further, Section 10 of the Motorized Snow Vehicles and All-Terrain Vehicles Act, 1990 authorize Council to make regulations:

• Permitting the driving of vehicles or a class of vehicles along or across a highway or part of a highway in a municipality;

Notice is hereby given that at the Public Council Meeting on \_\_\_\_\_, 2020, the following motion will be brought forward for consideration:

Pursuant to the powers vested in it by virtue of Section 201 and 202 of the City of Corner Brook Act, 1990 and section 10 of the Motorized Snow Vehicles and All-Terrain Vehicles Act, 1990 and all other enabling powers, the Council of the City of Corner Brook hereby amends the Recreational Vehicles Regulation 2019, by adding a revised Schedule A which will permit operation on more streets including Park Street, West Street, Confederation Drive and on Georgetown Road.

#### CITY OF CORNER BROOK RECREATIONAL VEHICLES REGULATION 2019

**Pursuant** to the provision of section 10 Motorized Snow Vehicles and All-Terrain Vehicles Act, R.S.N.L 1990 c. M-20 and sections 201 and 202 of the City of Corner Brook Act, R.S.N.L. 1990 c. C-15 and all other powers it enabling the Corner Brook City Council in a session convened on the <u>27th</u> day of May, 2019, hereby passes and enacts the following regulations:

#### Title

1. These Regulations may be cited as the City of Corner Brook Recreational Vehicles Regulation 2019.

#### Definitions

- 2. In these Regulations:
  - a. "All-terrain vehicle" means a wheeled motorized vehicle, excluding a two wheeled vehicle, designed or adapted for off-road use;
  - b. "City" means City of Corner Brook;
  - c. "Council" means Corner Brook City Council;
  - d. "Designated route" means any highway or public pathway approved by Council for all-terrain vehicle use and set out in Schedule A;
  - e. "Director" means the Director of Protective Services;
  - f. "Enforcement officer" means a municipal enforcement officer as defined by the *City of Corner Brook Act R.S.N.L. 1990 ch.C-15 as amended or* a peace officer as defined by the *Highway Traffic Act;*
  - g. "Highway" means any public highways, streets, roads or roadways, assumed and maintained under the ownership and jurisdiction of the City of Corner Brook;
  - h. "Highway Traffic Act" means the Newfoundland and Labrador Highway Traffic Act RSNL 1990 Chapter H-3 as amended;
  - i. "Motorized snow vehicle" means a tracked vehicle, commonly known as a snowmobile, where the driver sits astride a seat and which is designed for

- j. "Motorized Snow Vehicles and All-Terrain Vehicles Act" means the Newfoundland and Labrador Motorized Snow Vehicles and All-Terrain Vehicles Act, RSNL 1990 Chapter M-20;
- K. "Public pathway" means any pathway or trail assumed under the ownership of the City of Corner Brook or maintained under the jurisdiction of the City of Corner Brook;

#### **Designated Routes**

3. All-terrain vehicles, as defined by these regulations, are permitted to be used on any highway or pathway set out in Schedule A provided that they are operated in the manner as set forth in this regulation.

#### **Prohibited Routes**

- 4. Except as set out in Schedule A, no person shall use or permit to be used, an allterrain vehicle on a highway or public pathway within the City unless:
  - a. prior written permission has been obtained from the Director and/or City Manager; and
  - b. the person/s adheres to any or all additional conditions and restrictions set out by the Director or City Manager.

#### Snowmobiles

5. No person shall use or permit to be used a motorized snow vehicle on any highway within the City.

#### Rules of Operation

- 6. No person shall operate an all-terrain vehicle upon a City highway unless:
  - a. that person travels upon the designated route as outlined in Section 3 of these regulations;
  - b. the vehicle and its driver operate in accordance to the *Motorized Snow Vehicles and All-Terrain Vehicles Act*;

- c. that person is at least 16 years of age and the holder of a class of driver's licence issued under the *Highway Traffic Act*;
- that person or the vehicle being driven carries a liability insurance policy and proof thereof can be readily produced when requested by an enforcement officer;
- e. the all-terrain vehicle is equipped with an exhaust system that is of the original equipment manufacturer and has not been modified to increase sound. The exhaust system must be in working order and in constant operation to prevent excessive or unusual noise;
- f. the all-terrain vehicle must not ever exceed any posted speed limit and further shall be operated at a rate of speed not greater than 40 kilometres per hour on highways and not greater than 20 kilometres per hour on trails or pathways;
- g. the driver of an all-terrain vehicle at all times yields the right of way to drivers of all other classes of motor vehicles on a highway.

#### Rules of the Road

7. Unless otherwise stated in these regulations, the driver of an all-terrain vehicle shall adhere to the "rules of the road" as described in Part V of the Newfoundland *Highway Traffic Act* or any similar or successor legislation.

#### Times of Operation

- 8. No person shall operate an all-terrain vehicle in accordance with this bylaw before June 1<sup>st</sup> or after October 31<sup>st</sup> of any year.
- 9. No person shall operate an all-terrain vehicle within the City and upon its highways earlier than 7 A.M. and no later 10 P.M.

#### Signage

10. Council may erect Warning, Cautionary, Directional, Limiting or Prohibiting signs as to the operation of all-terrain vehicles and the operator of any vehicle who fails to obey such signs is guilty of an offence under these regulations.

#### Penalty

11. A person who contravenes or fails to comply with these regulations is guilty of an offence and where no penalty is otherwise prescribed for such offence in the *Motorized Snow Vehicles and All-Terrain Vehicles Act RSNL Ch.M-20, Highway Traffic Act RSNL 1990 ch. H-3* or any other Provincial Statutes or Regulations, is liable on summary conviction to a fine or to a period of imprisonment or both in accordance with section 438 of the City of Corner Brook Act RSNL 1990 Ch. C-15, as amended.

#### Exemption

12. These regulations do not apply to vehicles owned and operated on behalf of the Council or those operated by Emergency and or Enforcement Services and other persons who are exempt by the provisions of the Motorized Snow Vehicles and All-Terrain Vehicles Regulations 1163/96.

#### Interpretation

- 13. These Regulations include the Schedules attached to them, and the Schedules are hereby declared to form part of these Regulations.
- 14. If a court of competent jurisdiction should declare any section or part of a section of these Regulations to be invalid, such section or part of a section shall not be construed as having persuaded or influenced Council to pass the remainder of the Regulations and it is hereby declared that the remainder of the Regulations shall be valid and shall remain in force..

#### Coming into Force and Repeal

15. These regulations shall come into force as of the date enacted by Council and the City of Corner Brook Recreational Vehicles Regulations April 5, 2008 is hereby repealed upon the coming into force of these Regulations.

- Curing Street west of Georgetown Road intersection.
